Free apprenticeships for under 25s Eligibility

Free Apprenticeships for Under 25s offers fully subsidised training for more than 130 priority apprenticeship and traineeship qualifications.

To be eligible for free apprenticeships for under 25s, students will need to commence training in a high priority qualification with an approved Skills Assure Supplier (SAS) training provider within one of the high priority apprenticeship or traineeship qualifications commencing from 1 January 2021 to 30 Jun 2027.

Fee free training also applies to students who commenced in a high priority apprenticeship or traineeship in previous years, where they are under 25 years of age on 1 January 2021 to 30 June 2027 and are still in training.
